## Capitol Hill Update

Last week, President Eric Feldbaum, Madeline Wade (Brumidi Group) and Executive Director Brian Stith traveled to Washington, DC to meet with National Park Service Staff, Congressional Staff and Committee Staff about the merits of the Stateside LWCF Program. They were able to meet with congressional staff from Missouri, Oregon and New Hampshire. In addition, meetings were held with staff from the House Natural Resources Committee, House Appropriations Committee and the Senate Energy and Natural Resources Committee.

Overall, the meetings went well, and we are planning more meetings in the coming months. We also attended a reception hosted by the Outdoor Recreation Roundtable to celebrate the passage of the EXPLORE Act in December of 2024. The EXPLORE Act passed both legislative bodies with unprecedented bipartisan support and is an important piece of legislation for Outdoor Recreation. Among other things, it codified the Outdoor Recreation Legacy Partnership (ORLP) program and serves to improve outdoor recreation opportunities for all by improving accessibility and restoring and improving infrastructure.
